Introducing the thinnest, lightest Zebra mobile computer yet — the EC50 WiFi enterprise mobile computer. Designed to be individually assigned to workers, the EC50 gives your customers the power to meet the needs of every moment by delivering the best of all worlds — the great smartphone look and feel workers want in their business device, the durability for all-day everyday business, plus all the business features the users need to drive personal productivity, collaboration and device value to a new high.





The EC50 is ready for the future with support for payment options and RFID. Your customers get extreme flexibility — in just seconds, the same device that slips into a pocket can turn into a full workstation, a gun-style device that brings extreme comfort to scan intensive tasks, and a two-way radio or a PBX handset for better collaboration via voice and text. Easily find lost and misplaced devices, even when they are powered down, with Device Tracker.

6. LifeGuard for Android

LG is available on the EC50 and for devices covered by a Zebra OneCare active contract, it includes the following support:

10. Frequently Asked Questions

Q. What product in the Zebra portfolio is EC50 replacing?

A. The EC50 is a new category of individually assigned enterprise mobile computer in a smartphone-like form factor and hence not replacing any of the existing products within the Zebra portfolio.

Q. What OS will the EC50 release with?

A. The EC50 will release with Android 10.

Q: How can I charge my EC50?

A: There are a few different charging solutions. See section 2B for exact part numbers.

- USB C cable with wall adapter
- Low cost single slot charge only cradle
- Single-slot charge cradle with Ethernet connectivity
- 4-slot charge cradle (non-locking)
- 4-slot charge cradle (locking)
- · Workstation docking cradle
- 5-slot Ethernet & Charge Cradle

Q: Do I have to send the EC50 back to Zebra or find an authorized Services partner to change old worn-out batteries?

A: No, the EC50 allows end-user access to the battery for easy replacement of worn-out batteries or to switch to the extended battery.

Q: Is there a workstation cradle option for the EC50?

A: Yes, there is a workstation cradle kit, part number CRD-EC5X-1SWS-01, that can be purchased separately allowing connectivity to monitor, keyboard, printer, and other peripherals to provide a desktop experience.

Q: Is there a spare battery charger for the EC50?

A: No, there is no method to charge the battery outside of the device itself. The EC50 is intended to be individually assigned, however end-user does have access for easy replacement of worn-out batteries without having to send the device in for Services.

Q: Is there a version of the EC50 without a scanner?

A: Yes, we have a version of the EC50 without a scanner populated. In this version of the product line the scan keys are programmed to activate the rear camera for scanning.

Q. Will there be WWAN versions of the EC5X?

A. Future updates and associated DN and PMB will address availability of WWAN SKUs (EC55).

Q. For scan intensive use case, will there be a trigger handle accessory offered with the EC5X?



A. Yes, as noted in section 2B, TRG-EC5X-SNP1-01 is offered as a snap-on trigger handle that work with any EC5X with a 2-pin or 8-pin rear I/O connector. Devices with "no rear I/O connector" are NOT compatible with this trigger handle. As the rear I/O connectors are not field replaceable, please plan accordingly.

Q. Will there be RFID capability offered with the EC5X?

A. Future updates and associated DN and PMB will address availability of RFID optional sled. SKUs in section 2A that denote "8-pin back connector" in description are RFID-ready. As the rear I/O connectors are not field replaceable, please plan accordingly.

Q. What is the life cycle of the EC5X Series?

A. EC5X series is a 4x4 product. Four years of sales, and four years of service beyond the end of sale date of the device.
